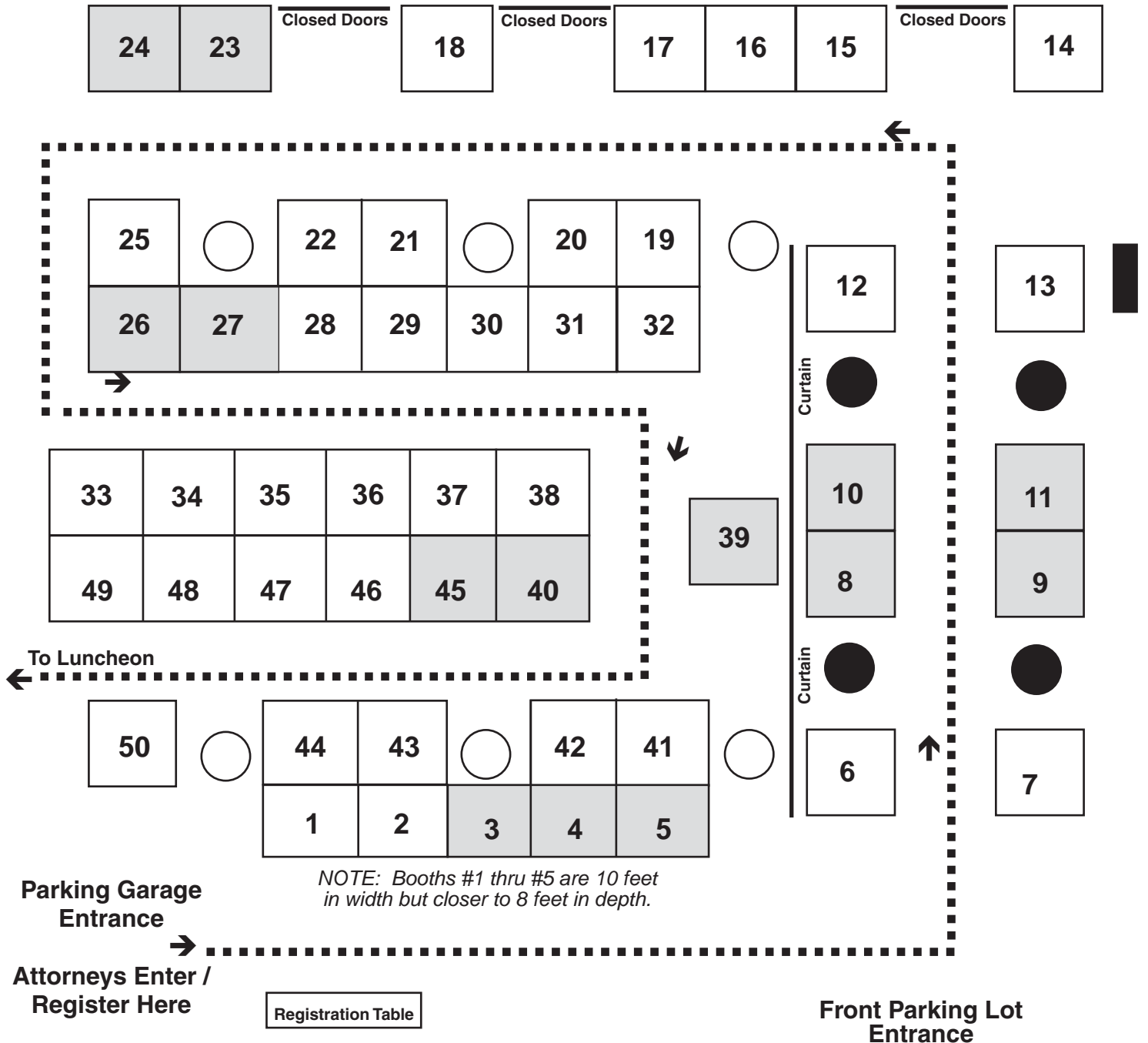

NO MEMBER MAY PURCHASE A LIST FOR USE BY A NON-MEMBER IN AN ATTEMPT TO CIRCUMVENT THIS REQUIREMENT FOR ANY OTHER PURPOSE.
