\$38 minimum, priced according to column inch of text.  
 For instance, 1 column inch wide x 1 inch deep of text equals \$38.  
 Ad includes text only and is only available in black ink.

## DEADLINES:

Editorial deadline: Two months prior to the publication date  
 Contract deadline: One and a half months prior to the publication date  
 Artwork deadline: Five weeks prior to the publication date

## CONTRACT DISCOUNTS:

Discounts are applied to the cost of each month.  
 BRBA will usually invoice on the 15th of each month.  
 Additional discounts to advertising agencies are not provided.  
 6-month contract: 10% discount
